

Belling Cashback Promotion Terms and Conditions

1. Information on how to claim the prepaid card cashback form part of these terms & conditions on offer. Participation in this promotion is deemed acceptance of these terms & conditions.
2. The Promoter is Glen Dimplex Australia Pty Ltd, 1340 Ferntree Gully Road, Scoresby VIC 3179. (ABN 69 118 275 460).
3. The offer is only open to residents of Australia aged 18 years and over. Employees and the immediate families of the Promoter and its agencies (including but not limited to Belling Dealers/Re-sellers) associated with this promotion are ineligible.

a) LAY-BY-CLAUSE: Please note that only lay-bys that have been initiated within the purchase period of 1st September 2020 and 30th September 2020 (inclusive) and paid in full by the promotion end date 30th September 2020 are eligible for the prepaid card cashback.

6. In order to make a valid claim, consumers must complete the online redemption form available at www.belling.com.au/promotions and submit a copy of proof of purchase/tax invoice showing full payment and details of the product purchased. Failure to complete this form in full (including the product serial numbers) or to provide an original proof of purchase showing the details of the product purchased, will lead to a rejection of the claim.

7. All redemption claims must be submitted online by no later than the 31th October 2020. The Promoter will not accept any claims after this date, as they are considered ineligible. If a customer has an issue with submitting their claim in full, they must contact the promoter **before** the promotion claim end date, of the 31^h October 2020.

8. The prepaid card of up to \$1500 value will be issued by Glen Dimplex Australia within 60 working days of the fully completed redemption claim being received and validated.

9. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting the place of purchase) and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these terms & conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at this stage does not constitute a waiver of these rights. The claimant agrees that if they have

obtained a prepaid card, they will pay back the Promoter the value of the card if they subsequently return the product to the place of purchase and seek a refund under any returns policy that the relevant retailer may have.

10. The Promoter does not accept responsibility for illegible, late or misdirected redemption claims.

11. Claimants must retain a copy of their proof of purchase/tax invoice for their claim. Failure to produce the proof of purchase/tax invoice for the claim when requested may, in the absolute discretion of the Promoter, result in invalidation of the claimants claim and the forfeit of the any right to the Prepaid card valued at up to \$1500. The proof of purchase/tax invoice must clearly specify the store of purchase, tax invoice number, purchase date, items purchased, prices paid and the claimant's details (full name and address, telephone number).

12. It is the responsibility of the claimant to provide the correct mailing address in order to receive their Prepaid card.

13. The Promoter does not accept responsibility for late, lost, damaged, stolen or misdirected mail.

14. This offer not transferable, assignable or exchangeable and cannot be taken as cash.

15. This offer cannot be used in conjunction with any other offer.

16. This offer is for retail customers only and there is no Prepaid card available for government, national accounts, contracts or not for profit organisations (unless the not for profit organisation is buying at retail pricing).

17. The promotion is not applicable to purchases of display models, graded seconds or factory reconditioned products.
